2018 NET PROFIT INFORMATION

Due Dates: Companies on a calendar year are required to file annual returns by April 15th. Companies on a fiscal year are required to file annual returns by the 15th day of the 4th month following the entity’s year-end.

Estimated Payments: Percentage of estimated tax liability must be paid by 15th day of fourth month 22.5%, 15th day of the sixth month 45%, 15th day of ninth month 67.5% and 15th day of twelfth month 90% to avoid penalty and interest charges.

Extensions: Fax (330) 668-9565 or mail a copy of your Federal Extension by the due date and you will be granted a city extension until the 15th day of the 10th month following the entity’s year-end.

Delinquency: For returns received after the due date or extension date a \$25 per month late filing fee will be imposed, maximum of \$150. In addition, penalty of 15% of tax due and interest of 6% of tax due per year will be imposed.

De Minimis: No remittance is required if the tax due is \$10 or less. Overpayments of \$10 or less will not be refunded.

2018 WITHHOLDING INFORMATION

Due Dates: Monthly filers are due by the 15th day of the month following the months end. Quarterly filers are due by the last day of the month following the end of each quarter.

Monthly Threshold: Payments are due monthly if prior year withholding taxes exceeded \$2,399; or withholding taxes in any month of preceding calendar quarter exceeded \$200.

Reconciliation: An annual reconciliation of your employees’ wages and copies of W-2s are due by the last day of February. For returns received after the due date a \$25 per month late filing fee will be imposed, maximum of \$150.

Delinquency: Penalty of 50% of tax due and interest of 6% of tax due per year will be imposed on tax received after the due date.

De Minimis: No remittance is required if the tax due is \$10 or less. Overpayments of \$10 or less will not be refunded.

Occasional Entrants: Employer is exempt from withholding taxes for employees working 20 or fewer days in Fairlawn.

TAX REVIEW BOARD

Any person dissatisfied with any ruling, decision, late fee, penalty or interest imposed by the Tax Administrator may appeal by written request to the Tax Review Board, c/o City of Fairlawn, PO Box 5433, Fairlawn OH 44334.
